Previously Opening Permission has been accorded for opening of classes VI-X (English Medium) during the year 2010-11 vide Progs. Rc. No. 2689/B2/2010, Dated 20.10.2010 of the Regional Joint Director of School Education, Kakinada in the reference 4<sup>th</sup> cited. The Correspondent, Jal Sri Saraswathi Devi Educational Society, Narsapur (Regd. No. 172/2009) has submitted the application for Provisional Recognition to the classes VI-X (English Medium) in the school for the years from 2010-11 to 2019-20 vide ref. 5<sup>th</sup> cited. The District Educational Officer, West Godavari, Eluru has verified the application for Provisional Recognition with reference to the Inspection Report of the Inspecting Officer and also with reference to the conditions laid down in the permission orders and G.O.Ms.No 1, Edn., dated 01-01-1994 vide ref. 7<sup>th</sup> cited. The Regional Joint Director of School Education, Kakinada hereby accords granting Provisional Recognition for a period of 10 (Ten) years i.e., for the academic years from 2010-11 to 2019-20 to the classes VI-X under English Medium in Swarnandhra International School, Palakol Road, Chinamamidipalli Village, Narsapur Mandal, West Godavari District.

That the society shall abide by the instructions/rules and regulations made by the Government or authorized officer from time to time.

1. That the Educational institutions shall serve the needs of the locality more particularly.
2. The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
3. That the school timing vacancies and mid-term holidays shall be followed as prescribed by Government from time to time.
4. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
5. That the results of institution shall be satisfactory every year.
6. That the records / accounts shall be furnished to the District Educational Officer, every year by 30<sup>th</sup> September at least.
7. That the list of Governing Body shall be furnished to the District Educational Officer every year.
8. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
9. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.
10. That the school shall not be closed without giving notice both to the parents / District Educational Officer, and competent authority at least six months before.
11. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
12. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., at least six months prior to the date of expiry of the present recognition.
13. That the society shall provide fire safety measures in the school.
14. The management informed that no thatched roof accommodation is allowed to run the School.
15. Proper and adequate sanitation facility shall be provided for students especially for girl students.
16. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
17. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
18. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
19. The school shall have first aid kit and the teachers shall be trained in first aid.
20. The Correspondent of the concerned school is hereby informed to file an affidavit to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
21. The management of the school is requested to obtain the No Objection Certificate from the Fire Service Department from time to time.
